3.	Review of the last meeting minutes	 UNDP, Chair of DRR WG shared the last meeting minutes and the participant reviewed. Meeting minutes is endorsed. Permanent Secretary shared the updated information concerning about Dam Management and Risks. Forest Department, GIS session will host workshop on 11th Nov 2015 to discuss on dam management & slide and those who are interested to join the workshop can request through RRD to participate in the workshop as DRR WG. 4.	Update on Community Disaster Resilience Framework from ADB	 Dr. Win Oo, the consultant of ADB presented on the update of community disaster resilience framework. The consultation process on developing the framework is intended to get a common understanding on strengthening community disaster resilience in Myanmar. As the first step, the consultation workshops was conducted in March 2015 and identified key sectors to be included in the framework. Then, ADB consultant already had meetings with specific government departments. ADB consultant is now preparing the draft framework but in the meeting with specific department, the information are not enough for some reasons. However, there are still gaps in gathering information and getting the ownership of government department. A wider consultation workshop with different departments and DRR WG could be an option to get the comprehensive inputs and the ownership of the stakeholders. Permanent Secretary suggested that the framework should be realistic and to consider which are realistic and which can be implemented in the rural areas. U Aung Min from MCDRR suggested to strengthen the participation of local NGOs in the process. Loy, MARS mentioned to share the draft documents to DRR WG and to invite the comments from DRR WG. ADB agreed to share the draft document to DRR WG. The participants also suggested a consultation workshop for further consultation. Last DRR WG, it was discussed and the committed agencies to support the DRM chapter are UNDP, UN-Habitat, Unicef, MARS, ADPC and JICA. The core team went through the data collection on DRM Sector, analyzed the needs of the needs of DRM sector and prioritized the projects. These are already presented in 13th Oct 2015 Forum. Loss and Damage Data, short term, medium term and long term are presented. Among all, 5 sectors are listed as top prioritized. (- Public Awareness and community engagement through CBDRM - Strengthening risk assessment and risk information systems - DRM financing and financial protection Strengthening disaster risk governance and mainstreaming - Enhancing Disaster Preparedness) The report was summited to PFLNA team. If there more updated news, UNDP will share the information to DRR WG. Loy suggested to discuss about DRR WG to take part or not in implementation of the recovery plan. U Aung Min suggested that DRR WG should participate in the preparation of the Recovery Plan.
