SCI conducted IYCF refresher training in Sittwe and Pauktaw on 20-21 September 2015 and 30 Community Development Facilitators and Counsellors participated in this training. Similar training was conducted in Oct 2015 again and 60 Counsellors attended the training. SCI accomplished planned cooking demonstrations, peer to peer group meetings and mother to mother support group meetings in October 2015 just to leave other routine activities to implement in November 2015. In OTP programme, 37 new cases were admitted and 28 discharged cured in September 2015.Weight for Height (WFH) will be used as one of the admission criteria probably starting from November 2015 in SCI OTP programme in Pauk Taw as well as in active screening in Sittwe rural areas. WFP requested SCI to use WSB in SCI's cooking demonstration sessions and it will support WSB to SCI. SCI requested UNICEF to available supplies for SCI's previous and current PCAs.
