Topic 2: Follow-up action on previous meeting minutes		
Summary of discussions	 Discussion: WASH cluster partner followed on action points; WASH cluster request the standard guideline of Resettlement and Relocation. 1st Aug SI follow up the Pamati camp process to government GAD through UNHCR. Maw Hpawng Lhaovo Baptist Church camp relocation site will provide WASH assistant by Shalom on coming quarter. Tanai 3 camps have covered by ICRC in April and up to now. 3-unit Septic tank, 800-gals elevated water tank 2 unit, 2 bathroom, 16 latrine, bathing space 4 unit renovation, drainage channel 500', WASH infrastructure of Palana and Trinity camp would be upgrade by ICRC due to requisition. WASH cluster request the WQ result data (Q1 and 2) from each agency Final version of HP strategy for Kachin/ N-Shan will be circulating on quarter 3 by C4D team from UNICEF. WASH cluster will send AAP Mechanism to cluster partners for reference in activity. WASH in Emergency Training detail schedule will be circulating to partners soon. WASH partners could be issue Abate Powder for IDP camp with request detail HH and PP list to Health cluster directly. 	
Action Points	 DDM provided 3 latrines and 1 water point at Pamati camp (Resettlement site). ICRC is going to implement WASH infrastructure and KMSS provide hygiene promotion sessions at Tanai 3 camps. Upgrading Water points from Palana and Trinity camp will have attached solar pumping system on this month by ICRC. Meeting participants agreed to follow up discussion on next meeting. 	

Topic 3: Revie	w on 2019 EPRP (Emergency Preparedness and Response Plan) in Kachin WASH Cluster
Summary of	Discussion & suggestion: WASH Cluster Coordinator discussion on following points;
discussions	 SI, ICRC and KBC have contingency stock and regular updated by quarterly that other cluster partners should have an emergency stock; relief items. 5 - 7 % funding should have allocated to EPRP programme. Health and WASH cluster have regular coordination and response plan on health issues as like AWD (Acute Watery Diarrhoea) or AGE (Acute Gestrointestinal Entric). WASH cluster member must be aware on WASH related item usage such as water quality testing, chlorination, and so on. WASH cluster have proposition stock for emergency response to 25000 affected PP.
Action points	 WASH cluster will share update contingency stock lists of DRD and UNICEF. WASH cluster members will be conduct the Emergency Preparedness and Response Training, will organize by SI on next month.

Summary of	Discussion: WASH cluster discussion on following points;		
discussions	• Total HH- 5274, PP – 25406 from Naung Mon, Waimaw, Myitkyina and Sadom tsp affected		
	flood in last month. DDM, MRCS, UNHCR and ICRC provide relief items such as food, mosquito		
	net, blankets, kitchen set, tarpaulin, plastic bucket, jerry can and NFI kits.		
	• DDM provided NFI kit (18 items contain) and cash assistance to flood affected people from Sinbo		
	(HH-33) and Tinyanzup (HH-6).		



	 KMSS was done flood rapid-assessment at 15 sites of 3 main area from Myitkyina. Regarding the result; water sources and latrine are mostly destroyed, 130 of 4000 people suffered diarrhoea. ECD suggested: it should be clear guide line on Method of emergency category step, Preparation step, Response step and coordination between Government departments and Humanitarian agency.
Action points	 KMSS prepare short-term response to flood affected people at 15 sites from Myitkyina. DDM will lead emergency response plan for Kachin on this month and Cluster leading agencies will be conduct. UNOCHA and UNICEF will organize Inter Cluster Coordination (ICCG) Meeting in this quarter.

Topic 5: Activity Gaps/ Funding gaps in Kachin IDPs based on Q2		
Summary of	Discussion: WASH cluster and partners discussion on following points;	
discussions	 Some agencies have no WQ test kits that have Water quality testing activity gap in last quarter. The should be coordinate with DRD to proceed activity. KMSS, KBC and SI applied MHF 1st allocation budget that have fill the gap. There are 74 IDPs/Returnees students (from grade 1 to 7) and 10 teachers in Sein Lone Post Primary school, there have toilets as apparently septic tanks not adapted, and DoE doesn't plan for additional support. 	
Action points	 Gravity Flow System activity is pending at Shingjyai camp, KBC targeted. WASH cluster will provide water quality analysing training on August and invitation letter will circulate in 2nd week of Aug. WASH cluster follow up on DoE and ICRC for response of Sein Lone school activity. WASH cluster and KBC have to follow-up on Na Ta La for Shingjyai camp water supply.

Summary of	Discussion: WASH cluster and partners discussion on following points;	
discussions	 40 of 85 HH from Sadom relocated to Sanar village. Na Ta La (MoBA) constructed individual houses and its included water supply system and latrine. 	
Action points	 UNOCHA and UNICEF will follow-up on Sadom (Camp like setting) in this quarter. DDM prepared Camp closure strategy (0 Draft) and will be finalize on this year.

Summary of	Discussion: WASH Cluster and SI lead on following discussion points;	
discussions	 Hygiene Promotion TWG – ToR revise version through agreed with SI and WASH cluster member. Update work plan for next six months through agreed with HP TWG members and finalize by SI (TWG leader). Cluster partners should have send existing hygiene promotion activities challenge and lesson
