Topic 1: Desludging Technical Working group and add solid waste disposal ToR into Desludging TWG				
Summary of discussions	Kachin WASH Cluster coordinator explained about the objective and agenda of this meeting and shared about existing situation of desludging and solid waste management system in IDPs camps and this meeting aimed for not only sewage disposal system but also other solid waste management system. Last meeting of Desludging TWG was held on 9 October 2015 led by Kachin based Oxfam WASH team. This meeting was re-activated TWG among WASH Cluster partners in Kachin including Government concerned departments.			
Action points	Oxfam will carry out to organize the coming Desludging and Solid Waste Disposal TWG meeting.			
Topic 2: Introduce rese	arch on Market Desludging Work (OXFAM)			
Summary of discussions	Oxfam WASH and Market advisor explained the overview of Desludging Market work in Myitkyina including general support, market survey and design of treatment. Research period will take from Nov 2017 to Aug 2018. TDC and other interesting TWG members also agree to participate in this process.			
Action points	Oxfam will to conduct with TDA, GAD and Principal of Myitkyina Technology University for Survey on Desludging market work around Myitkyina municipality area including IDP camps in Waing Maw and Myitkyina in coming January and February 2018.			
Topic 3: Technical prese	entation including challenges and constraints (by KBC, SI and KDG)			
Summary of discussion	 KBC-HDD WATSAN Technician shared presentation on existing situation of Desludging activities among IDPs Camps including collection, transportation, treatment, and disposal management. KBC also shared their challenging part of desludging activities which are transportation and collection (especially during emptying the pits, used sanitary pads are blocked with pump strainer). WASH Cluster coordinator also explained pros and cons of On-site and Off-site Desludging technique. WASH Program Manager from SI-Bhamo presented by PowerPoint their supporting to desludging for the IDPs camps in Bhamo, Momauk and Lwegel townships. Total 150 pits of 380 latrines have been desludging in targeted townships. They have supported by coordination with Camp leaders and meeting with community and 			





	especially engagement with respective TDA for desludging activities. She also explained about the detail description on methodology & technical specification of desludging and shared their technical challenges, key issues and way forward.		
Action points	.Next Desludging TWG meeting, WASH Cluster partners agreed to present on more detail especially desludging monitoring, cost analysis, sludge volume in IDP camps vs frequency of emptying pits, rural camp setting emptying pits & decommissioning for old latrine pits in IDP camps, etc		
Topic 4: Standard Operation Coordinator)	eration Procedures and guidelines for desludging activities (Kachin WASH Cluster		
Summary of discussion	Kachin WASH Cluster coordinator also suggested that all WASH partners who implement fecal sludge management at IDP camps should follow Cluster Standard Operations Procedure including on-site and off-site desludging system.		
Action points	All participants agree to follow SOP for fecal sludge management among IDP camps including collection, transporting, treatment and dispose.		
Topic 5: Urban Sanitat	ion in Kachin (Kachin State Development Affairs- State Municipality)		
Summary of discussion	DYSE from Kachin State Development Affairs explained about the Town Water Supply System, Solid Waste Management System in IDPS Camps and Supporting Desludging Service in Kachin State. They have been implementing for Town Water Supply System in Myitkyina, Putao and Hopin. Myitkyina project has being implemented by JICA ODA Loan, Putao project was implemented by Htoo Company private well wisher and Hopin project is implementing by BOT system by Htein Lon San Water Company. He also detail explained about the services to IDPs Camps for the Solid Waste Management and Desludging together with KMSS and Shalom-Nygien Foundation.		
Action points	Myitkyina TDA has a plan to procure new desludging trucks in coming Jan-Feb 2018 to provide better services for public in Myitkyina.
