Topic 3: Upda	ate from WASH Cluster					
Summary of	NFIs distribution:					
discussion	 WASH cluster have compiled data for NFIs distribution in 3rd week of November. All the distribution took place in cRS. Drastic improvement has been noted in terms of distribution in the month of November. Ditsribution activities have almost been stopped after 25th August incidence and IDPs in camps haven't re- 					

ceived their kits in last three-four months. Further distribution is planned end of Nov and in the month of December.

 Major gaps in PYG (DRC), OTC, KDK 1, SYK 1 (CDN), Taung Paw, Kanthar (Myebon, RI).

WASH in Schools:

Cluster Coordinator briefed partners on the activities being undertaken by some of the partners in schools. It was observed that very poor response have been extended to the cluster in acquiring data for schools WASH or the number of partners working in schools is very limited.

As per the compiled data only SCI and SI have been working in schools in camps in Pauktaw, Ponnegyum and Sittwe. It has been noted during the meeting that some other partners are also working in schools and are accordingly requested to share their detail of activities with WASH Cluster.

Ways of working for WASH Cluster:

WASH Cluster at country level and at State level have drafted a document defining ways of working. After consultation and feedback from the cluster team, "ways of working" document is being prepared to help standardize how we operate and coordinate in country. This document is for both national and sub-national cluster teams. Per the document, major responsibilities of WASH Cluster are as following.

- 1- Support service delivery
- 2- Inform strategic decision making
- 3- Plan implement strategies, Tech standards, clarify funding requirements,
- 4- Monitoring & reporting
- 5- Build capacity in preparedness and contingency planning
- 6- Robust Advocacy

Document will be circulated as annexure to the draft minutes.

WASH Cluster 2018 Calendar:

WASH Cluster presented calendar for 2018. Apart from routine cluster meetings/TWG meetings, WASH Cluster Rakhine aims to arrange two "WASH in Emergencies" training for cluster members and Gov't counterparts, and hold two strategic Review workshop in year 2018.

Draft calendar attached as annexure with the minutes. This calendar is to be updated with trainings once discussed with the partners.

TWiGs:

Discussions held on the way forward of Technical working groups of WASH Cluster. It was agreed that Social behavior and Water Quality topics to be prioritized in the TWiGs and later on may accordingly change as per the evolving needs and situation. The last minutes of the TWiG on the contingency plan will be shared, and Cluster partners to be associated. In order to move ahead with the process, it was agreed that 1st meeting of the TWiG will be held on 6th Dec to agree on the working modalities of TWiG.

Assessment in Sittwe Camps:

Rakhine State Gov't requested CCCM and WASH Cluster to carry out a rapid assessment in Sittwe camps in order to identify the gaps and critical priorities. This may be carried out in early December in collaboration with CCCM cluster. WASH and CCCM cluster will work on the way forward for assessment and partners are requested to extend their volunteer support for carrying out assessment.

Dry Season Planning for 2018:

WASH Cluster Coordinator briefed the partners regarding the challenges and opportunities in dry seasons. Major gap in last years was the provision of clean drinking water which was mainly undertaken through boating to different camps. It was also emphasized that dry season may also be a good period to capitalize more on reconstruction/rehabilitation activities which is usually not possible in rainy seasons. WASH Cluster coordinator further quoted that a working plan will be discussed with all potential partners and UNICEF for responding to the extra needs in camps in dry season. SI is already in discussion with UNICEF to sign a PCA for 2018 water shortage season and water boating activity for ANY camp (Pauktaw).

WASH Cluster Capacity plan 2018:

WASH Cluster coordinator briefed participants about this initiative by Rakhine cluster. It was observed that cluster partners particularly local organizations, Gov't counterparts and camp based staff needs to be trained on critical topics in WASH. Rakhine

WASH Cluster will work on in-house capacity building expertise for year 2018 and will request cluster partners to extend their contributions/resources in terms of financial and human expertise. Cluster will mainly prioritize below topics in the coming year.

- Desludging, EPRP, Protection/Gender mainstreaming in WASH, Ageing and disability in WASH, Communication in Emergencies, WASH in Schools, Water Supply management in emergencies, Emergency water supply standards and options, Water Quality, Humanitarian coordination structure, WASH Cluster and its mandate, Sphere standards, Assessments in emergencies.

Any further suggestions in this regard will be highly appreciated.

CDC CWF Study:

This was study was started in mid- August in order to gauge the effectiveness of Ceramic water filters but due to the 25th August incidence the study could not be completed on time. Now as the situation moving towards normalcy, WASH Cluster aims to complete the study by conducting remaining two days of field data collection with the help of field enumerators. The enumerators have already been trained by CDC team. The data collection will be carried out in Pauktaw, Sittwe and Kyauktaw townships in cRS on 29th and 30th November 2017.

Cluster Updates:

- WASH Cluster partners have started distribution of hygiene kits in different locations of Pauktaw township camps and in Sittwe camps. So far distribution have taken place in ANY, Sin Tet Maw and NC 2. Hygiene kits have also been distributed in some of the camps in Sittwe by Oxfam and SI. Following issues of population verification in NC 1, the distribution was delayed for many days. When it was finally organized, community tensions led to an incident on one of SI camp based staff (assault) during the distribution. There are some issues of population verification in NC 1 and UNICEF is in coordination with Camp management agency (LWF) to resolve the issues.
- Protection mainstreaming in WASH was discussed and partners requested for further orientation/training of field based staff.

Action Plan

- WASH Cluster partners to prioritize the areas which are due to receive WASH NFIs.
- Cluster partners are requested to share their details of WASH activities in schools.
- Interested Cluster partners are requested to participate in the TWiG on 6th December in UNICEF office.
- WASH Cluster to invite partners for TWiG.

• Cluster partners to extend their support on capacity building exercise for 2018.

Topic 4: Update from WASH Cluster Partners

Summary of discussion

- Oxfam presented findings of their recently conducted workshop on Tiger worm in Sittwe.
- RI mentioned that they have been facing some issues regarding transportation/distribution of NFIs in Myebon TA. Cluster assured RI that adequate support would be extended in order to carry out their plan activities. Apart from this RI is regularly conducting hygiene promotion sessions in Schools and communities
- DRC contract in Kyien Ni Pyin (KNP) will be expiring end of November and their might be possibilities of some gaps in services delivery in camp.
- CDN- New latrine construction is going on through contractor in both OTC and KDK 2 camps, Sittwe Township.
- SCI need lab support for STMG water quality Oxfam/SI setting up the lab and can discuss with SCI

Action Plan

- DRC/UNICEF to plan a joint visit to KNP camp and agree on the scope of work to be carried out in camp.
- RI to keep the cluster informed in case of any further delays/issues in transportation/distribution of NFS.
