

SITUATION OVERVIEW

Humanitarian needs persist in Myanmar due to ongoing armed conflict in Kachin and northern Shan States and continuing inter-communal tensions in Rakhine State. 240,000 people remain displaced. Largely as a result of restrictions on their movement and limited access to livelihood opportunities, many of the displaced remain highly dependent on humanitarian assistance. Shelters require reconstruction and items distributed early on in the crisis need replacing.

The 2015 Humanitarian Response Plan is part of a broader engagement by the United Nations and its partners in Myanmar to build peace and aid recovery and longer-term development. The plan aims to protect the people affected by conflict and disaster in Rakhine, Kachin and Shan, the three States with the most urgent humanitarian needs. Projects are designed to save lives and protect wellbeing; ensure equitable access to basic services and livelihoods and strengthen resilience to shocks from future conflict and disaster, including through early recovery and durable solutions initiatives. The strategy also stresses the importance of the commitment to joint advocacy, communications with affected people and conflict sensitivity.

GOAL OF HUMANITARIAN PARTNERS

To support the Government of the Republic of the Union of Myanmar and local communities to ensure that the lives, dignity and well-being of people affected by conflict and disaster are protected.

STRATEGIC OBJECTIVES

- Ensure that the life-saving protection and assistance needs of people affected by conflict and/or disasters are met;
- Ensure that people affected by conflict and/or disasters have equitable access to basic services and livelihoods opportunities;
- Enhance the resilience of communities to conflict and natural disasters and contribute to early recovery and durable solutions

DONATING THROUGH THE CENTRAL EMERGENCY RESPONSE FUND (CERF)

The CERF provides rapid initial funding for life-saving actions at the onset of emergencies and for poorly funded, essential humanitarian operations in protracted crises. The OCHA-managed CERF receives contributions from various donors – mainly governments, but also private companies, foundations, charities and individuals – which are combined into a single fund, to be used for crises anywhere in the world. the Humanitarian Community in Myanmar will be able to deliver life-saving and protection assistance to the most vulnerable people in Rakhine, Kachin and northern Shan states.

- **306,000 crisis-affected people** will receive food and/or cash assistance.
- 2 184,000 crisis-affected people will have access to basic health care services.
- 90,000 crisis-affected children will have access to education.
- 10,000 crisis-affected children will receive therapeutic care for severe acute malnutrition.
- 5 206,000 crisis-affected people will have adequate shelter.
- **428,000 crisis-affected people** will have safe drinking and domestic water.
