# Première Urgence Internationale (PUI)

Première Urgence Internationale is a non-governmental, non-profit, non-political and non-religious international aid organization. Our teams are committed to supporting civilian victims of marginalization and exclusion, those hit by natural disasters, wars, and economic collapses, by responding to their fundamental needs. Our aim is to provide relief to uprooted people in order to help them recover their dignity and regain self-sufficiency. Main sectors providing assistance to around 4 million people in 22 countries in Africa, Asia, Middle East, South Caucasus and France: Health, WASH, Food Security and Nutrition, Shelter and Economic Recovery.

PUI has been working for the people of Myanmar on health and related issues since 1983, as **Aid Medical Internationale (AMI).** The merger of PU and AMI in 2011 strengthened our ability to provide integrated, multi-sector approaches utilizing the combined organisations' experience resulting in more diverse programming and intervention possibilities. PUI's mandate to respond to emergencies remains a priority, while maintaining a longer-term development focus to adapt to the contextual needs of the population in Myanmar. Our projects have spanned several areas of the country including Shan, Kayin as well as south Yangon areas.

### Job Purpose

The **Peer Monitor** guides outreach workers and peer educators to smooth and accurate the referral process from project areas to NAP (ART Initiate Center) and follow up and home based care in Dala, Seikkyi, Twan Tay Kaw Hmu and Kun Chan Kone and Thanlyin townships under the direct supervision of HIV prevention Officer with the guidance of HIV Prevention Manager and closely collaborate with Peer Monitor Supervisors and Peer Monitors.

# Responsibilities

#### 1. General tasks for Case Management program

- Collaborate with peer monitors and peer educators for case referral process
- Empower and facilitate peer educators in peer support program in ART initiate Centre and Decentralized sites.
- Identify training needs for peers
- Identification and sensitization of high risks groups
- Implementation of BCC activities through peer monitors and peer educators
- Participate in the training programs and in other organization activities.
- Participate in the development of adapted IEC materials. s
- Participate in need assessment studies carried out in the field of Health Education.
- Facilitate beneficiaries to access health care in NAP.
- Assist the HIV Prevention Supervisor in designing, supervising and implementing new BCC strategy on HIV/AIDS prevention
- Facilitate the strengthening of Peer Support Program and Peer Entry Points in NAP DC sites.

### 2. Health Education

- Psycho-social support for beneficiaries before and after case referral to NAP and DC sites.
- Carry out training programs for the peers and other specific groups: conducts training of Peer Educators according to work plan in HIV prevention new strategy and case management model.

#### 3. Monitoring and reporting

- Maintain proper recording of all activities and establish daily, weekly and monthly reports
- Strongly focus & follow up case management activities and peer education prevention activities.
- Actively participate in data collection, monitoring & evaluation of the project.
- Strongly focus on data analysis, recording as well as newly positive case, number of referral and confirmed positive feedback from NAP sites.

#### 3) Mobile Testing and case management

- Assist the mobile testing team
- Inform his hierarchy the needs of target group for STI/HIV testing.
- Participate in the preparation of HIV testing in project area whenever necessary
- Positive case management activity with the help of peer monitors and peer educators.
- Follow up visit to case after referral for adherence and regular follow up to NAP
- Strengthen referred positive case to strong positive living and BCC change.

#### 4. Training and Civil Society Organization

- Participate in the preparation and implementation of peers and peer educators' training &CSOs activities
- Strengthen CSOs to participate case management model and referral process.
- Empower peer participation in NAP sites.

#### 5. Others

- Respect the principles of confidentiality and privacy
- Keep good relationship with other PU-I Staffs and implementing partners
- Regularly learn to improve individual skill on topics related to work and sharing with team members.
- Participate in meetings and coordination
- Assist Peer Monitor Supervisor and HIV prevention Officer when required.

#### **Requirements:**

- Bachelor degree or relevant background qualification.
- Previous work experience of similar position is preferable.
- Previous experience working in INGOs, LNGO is preferable.
- Willing to work for marginalized population in clinic based setting.
- Good communication skills between the clients and staff and among the team.
- Strong knowledge and strong mind to keep confidentiality for the clients.
- Able to analyze and solve the problems and define and decide the priorities.
- Able to take part in specific training and meeting for sharing knowledge and skills.
- Team work and team spirit with strong motivation to work for community
- Able to work under little supervision to complete tasks in timely manner.
