3. Announcement

- WHO informed that Environmental Sanitation Division from DoH is the focal agency for development of Water Safety Plan. WHO had circulated Manual on water safety planning in English version and it would be translated into Myanmar and would be used in the field. It was requested to the agencies to give feedback on it. WHO would like to have detailed guideline on shallow tube well management incommunity. A workshop on WSP guideline development would be organized in March.
- Malteser– informed that Malteser and ADRA started programmes for women and child health, livelihood and WASH in Hlaingbwe and Pa-an Townships in Kayin States. Malteser is covering GCA and ADRA is covering NGCA. The project also includedmine risk reduction activity.
- IRC WASH assessment was carried out at west bank of Than Lwin River and the activities were being planned to be implemented.
- WVI –Proposal prepared for donor for emergency response in Waingmaw, KachinState and recruitment process was underway.
- **UNICEF** informed that the cluster coordinator for WASH was travelling to Myitkyina and agencies involved in the emergency response related to WASH were invited to participate in the coordination meetings.
- **4.** Presentation on "F-CUBED direct solar water desalination/purification technology" by Mohammed P Khan, F-CUBED Bangladesh(20 mins.)
- F-cubed made presentation on solar water desalination/purification technology (please see attached presentation file). Mohammad explained F-cubed and their project in Bangladesh and other Asia countries. This device could be used for any types of raw water, no energy except solar required for the process with minimum requirement for maintenance.
- ACF, Malterser, WHO, UNICEF, Oxfam and IRC discussed on the on future plan for Myanmar, production capacities, plan for local production etc. in connection with the presentation and the product.
